01. Mediation Boards Act

Powers and Functions of the Commission	<ul style="list-style-type: none">• Appoint• Transfer• Dismiss mediators• Exercise Disciplinary control over mediators for the purposes of this Act• Supervise and control the mediators• Issue directions to the mediators
Powers of Mediation Boards	<p>A Mediation Board has the power to act in relation to a dispute or an offence that fulfills the following conditions.</p> <p><u>01.Disputes</u> A dispute arising wholly or partially within that Mediation Board area. Constitution of Mediation Boards	<ul style="list-style-type: none"> ● Providing opportunity for each party to select one mediator and such mediators selecting the third mediator (Chief Mediator) ● Providing opportunity to select one out of the Mediation Boards constituted previously, with the consent of both parties.
Duties of Mediation Board	<ul style="list-style-type: none"> ● Endeavour to bring the disputants to an amicable settlement by lawful means. ● Wherever practicable, remove the real cause of dispute, with the consent of the parties as well. ● Concluding its functions within the period prescribed by Section 13.

Settlement Certificate	<ul style="list-style-type: none"> • Where the disputants agree to a settlement, immediate issue of a copy of the certificate of settlement to the parties. • Sending copies to the court/police if relevant.
Time limit for the Board.	<ul style="list-style-type: none"> • 60 days in case of a dispute • 30 days in case of an offence (from the date the dispute was assigned to a Board)

Privileges of Witnesses	Every person who makes a statement before a Mediation Board shall in respect of such statement be entitled to all the privileges which a witness giving evidence before a court of law is entitled to in respect of such evidence.
Prescription	In computing the period of prescription, in regard to any cause of action or offence, the period commencing on the date on which an application is made to the Chairman of a Panel of Mediators in respect of the dispute constituting such cause of action or such offence and ending on the date of issue of non settlement certificate shall be disregarded.
Offence settled by a Mediation Board deemed to be compounded	Any offence settled by a Mediation Board shall be deemed to have been compounded within the meaning and for the purpose of the Code of Criminal Procedure Act, No. 15 of 1979.
Obtaining the assistance of Grama Seva Niladharis	Any Mediation Board may, in carrying out its duties, require the assistance of any Grama Seva Niladhari to communicate any notification to a disputant or other person, and such Grama Seva Niladhari shall when so required, render all such assistance as may be necessary in that regard to such Board.

	The Minister may make regulations in respect of any matter in respect of which regulations are authorized by this Act to be made or required by this Act to be prescribed.
Interpretation	<ul style="list-style-type: none"> • Disputant - Any party to a dispute or any person involved in the commission of an alleged offence or any person against whom any offence is alleged to have been committed. • Chief Mediator - The third mediator selected at the discretion of the two mediators selected by the two parties when the Board is appointed following the first method under Section 9 or the member of the Board appointed by the Chairman of the Panel following the second method.

02. Definition of Mediation

Mediation is an interactive process of assisting all the parties to a dispute to voluntarily enter into a mutually satisfactory settlement that would

- fulfill their needs
- remove the root cause for the dispute

05. The Five Steps

First Step

- Welcome
- Introduce and get to know
- Explain the role of the mediator
- Explain the mediation process
- Matters to agree upon
 - Not interrupting each other
 - Not using defamatory, sarcastic language
 - Speaking in turns
 - Switching off the mobile phones
- Confidentiality

Second Step

- Identifying the content of the problem in brief and preparing an agenda

Third Step

- In depth study of the problem and exploring the positions and requirements.

Fourth Step

- Option generation

Fifth Step

- Drafting and signing the agreement

06. Principles of the Mediation Process

- Self determination – Accepting responsibility for one’s self and right to make decisions regarding one’s self
- Cooperation – Working together with a common goal

- Respect – Accepting people as they are/ appreciating, not judging the parties and being open towards them
- Justice – A process that delivers justice and equity to both parties
- Equality- Ensuring that both parties are provided equal opportunities
- Recognition – Recognition among parties and reception
- Empowering – Building confidence in the disputants to express their views with clarity and that they have strength to settle the issue
- Flexibility- A process that can be adapted according to the wishes of the disputants.

07. What is successful mediation?

- Reaching a settlement mutually accepted by both parties.
- Removal of the root cause for the dispute.
- Relationship between the parties has been rebuilt as appropriate.
- Settlement of the long term dispute.
- Mediators have not used force or influence.
- Parties have not been discriminated against based on race, religion, caste or gender.
- All parties affected by the agreement being satisfied about it.
- Agreement has been entered into in a fair, intelligent and efficient manner.
- Communication techniques for mediation have been used.
- Five steps of mediation have been followed.

08. Code of Ethics for Mediators

- Maintaining dignity and courtesy
- In conducting mediation sessions, functioning in line with the training provided
- Being courteous to the disputants

- Should provide sufficient opportunity to the parties to explain matters
- Participating in the mediation sessions from the beginning to the end and not neglecting to participate in those sessions
- Should function in a mediation board only if satisfied about being capable of speedy and impartial mediation
- In mediation sessions, mediators should be impartial and neutral and also appear to be impartial and neutral at all times
- If a mediator has any connection to any disputant or to the dispute or its consequences, he or she should not function in such mediation board
- Mediator should ensure the confidentiality of all the information received by him or her during mediation process
- Respecting the disputants' right to self determination
- Assisting the disputant
- Maintaining a pleasant appearance
- Avoiding harmful behavior
- Not expecting personal benefits
